This First Amendment further effectively amends the advertisement dated 31 October 2019, solely to the extent of Date of issue of provisional list of prospective resolution applicants, Last date for submission of objections to provisional list, Date of issue of final list of prospective resolution applicants, Date of issue of information memorandum, evaluation matrix and request for resolution plans to prospective resolution applicants and Last date for submission of resolution plans.
